## **Michigan Preliminary Drumming Results for 2009**

Due to personnel limitations, the ruffed grouse drumming survey was not conducted statewide in 2009. However, 42 drumming routes were run in the Upper Peninsula. In 2008, 50 drumming routes were run in the Upper Peninsula. A paired t-test was performed using data from the 42 routes run in both years. There was no difference ( $P=0.6$ ) in the average number of drums heard per route between 2008 (18.9) and 2009 (18). Because routes were not conducted in Ontonagon and Gogebic counties in 2009, results do not represent those counties.

Ruffed grouse populations have exhibited ten-year cycles in abundance over much of Canada, Alaska, and the Great Lakes states of Wisconsin, Minnesota, and Michigan (Rusch et al. 1999). Many factors affect grouse populations including changes in habitat and food availability. It is unclear why the population cycles occur, but many theories have been proposed (Rusch 1989). The population in Michigan is expected to peak in 2010.

## **Merging of Michigan Departments Expected**

Gov. Jennifer Granholm is expected to issue an executive order that will merge the Departments of Agriculture, Environmental Quality and Natural Resources, according to comments Lt. Gov. John Cherry. "I don't want to be held to an exact date, but I'm kind of seeing that this fall there will be an executive order that will combine the three departments."

Cherry stressed that consolidation wouldn't solve the budget problem, but that's not the primary force behind the streamlining effort, which Cherry was appointed earlier this year to oversee for the administration. Cherry's comments have ignited some buzz in Lansing, where opinions are split over such a combination. Sen. Michelle McManus (R-Lake Leelanau) said she heard rumors all week that an executive order was imminent. As the sponsor of legislation to combine the DEQ and DNR, McManus said she opposes putting the Department of Agriculture (MDA) in the mix without some input and discussion from the groups that would be involved in a combination.

**"Agriculture is the only industry that is thriving in this state and it's disappointing that this administration hasn't recognized that," McManus said. "It's important that this particular department stays at the top of what the administration does with reorganizations, either as a stand-alone department or, if it combined, highlighted in some fashion."**

**According to Mike Zagata, RGS Executive Director and CEO, "Bruce is the ideal fit with what we look for in a Regional Director. He has the educational background, people skills and experience with volunteers to assist his current chapter volunteers and to bring together other folks interested in the wildlife that depend upon young forests for their survival to form new chapters. Michigan is an important state for the Society, and we needed someone who could send that signal - Bruce is that person."**

# **Preliminary Ten-Week Wisconsin Brood Survey Results**

**Brood rearing conditions in Wisconsin in 2009 were cooler and significantly dryer than they were in 2008. Most of Wisconsin experienced a cool summer, with the average daily temperature running 1 to 3.5 degrees Fahrenheit cooler than normal. Precipitation was average to below over most of the state. No major weather events should have affected the brood rearing season like in 2008.**

**Statewide, ruffed grouse broods seen per observer hour was up 31% compared to 2008. Ruffed Grouse production was up in 2 of the 3 regions that compose the primary range for ruffed grouse, the northeast and northern regions, while the west central region showed no change from last year. Statewide however, grouse production did remain below the long-term average. Ruffed grouse brood size remained unchanged from last year with broods averaging 4.4 young per brood. Spring breeding grouse numbers were higher than 2008 levels and so is grouse production. While some areas of the primary ruffed grouse range will be better than others, it appears that ruffed grouse numbers this fall will be better than the previous 3-4 years and are well on their way to their cyclic high.**

## **Draft Wisconsin Statewide Forest Assessment Comment Period Open**

**The public is invited to review a draft of the 2010 *Statewide Forest Assessment*, an appraisal of Wisconsin's public and private forests and of the sustainability of the state's forested ecosystems. The *Assessment* will be integral in the detailed planning processes undertaken by the Forestry Division of the Wisconsin Department of Natural Resources and its private- and public-sector partners. The *Assessment* will include analyses of the following: productive capacity, forest structure, forest health risks, fire, recreation, the state's wood products industry, the state's forestry workforce, laws that govern the way forests are used and managed, and the investments in forest-related research and education.**

Anyone who is interested in forests and forestry in Wisconsin is invited to offer comments on the *Assessment* by October 15. The goal is to review the *Assessment* from a wide range of perspectives. ## Tree and Shrub Seedlings Available from Wisconsin State Nurseries

Starting the first week of October, Wisconsin's Nursery Program will begin accepting orders for trees and shrubs for delivery in April and May of 2010. The seedlings from the Nursery Program are quality species native to Wisconsin. They are to be used for private, industrial, and state/county reforestation and conservation plantings (rather than ornamental, landscaping, and/or Christmas tree production). In addition to order requirements, landowners participating in the Managed Forest Law (MFL) Program will receive information on new Forest Stewardship Council guidelines.

The State Nursery seedlings can also be purchased by state youth groups and educational organizations for reforestation/conservation plantings. Anyone looking to buy seedlings is strongly encouraged to place an order early because some species sell out quickly. Bill Reintroduced to Have the Wisconsin DNR Secretary Appointed by the DNR Board

*Your Input Sought for a Followup Survey*

During the current Wisconsin legislative session, Assembly Bill 138 and companion Senate Bill 113 have been reintroduced. Named "Eliminating

**Political Control of the DNR”, this bill would once again remove the appointment of the Department of Natural Resources Secretary from the governor and give it back to the DNR Board, a situation that occurred. When the DNR secretary is appointed by the governor, he or she is accountable to the governor. The bill purports this can lead to partisan politics infusing it into day-to-day natural resources policies.**

**According to State Representative Kevin Petersen (40th Assembly District), there is a fundamental problem with the current bill. Absent this session is complementary legislation that he had co-sponsored ensuring the Department of Natural Resources Board is represented by all of Wisconsin’s natural resources community.**

**As the legislation read last session, representation on the board would have included at least three members of the Natural Resources Board must have held an annual hunting, fishing, or trapping license seven out of the previous ten years, and at least one member of the board will have an agriculture background. Exceptions would have made for military personnel who have been on active duty.**

**Representative Petersen has set up an informal survey to gauge public opinion. His questions is: If the Natural Resources Board appointed by the Governor is not required to have a sporting, recreational, and agricultural mix of members, would you still be supportive of the Secretary being appointed by the DNR Board?
