# **2011 REGIONAL BIOLOGIST REPORT**

## **Here's a summary of the 2011 Regional accomplishments:**

- Attended 49 meetings with resource agency staff/legislators and provided RGS input to 15 public land management projects.
- Involved in 24 media contacts (includes press releases/television and radio interviews).
- Conducted 9 reviews of existing or proposed Management Area Projects.
- Conducted 9 on-site habitat consultations.
- Participated in 14 chapter meetings, 2 youth events, 4 outdoor shows and 3 field events.
- Attended 9 chapter banquets.
- Responded to approximately 1,500 individual requests for information.
- Produced four FAN Update newsletters to about 700 members.
- Represented RGS on Lake States Resource Alliance, Great Lakes Timber Professionals Association, WI DNR Grouse and Woodcock Committee, UP Michigan DNR Habitat Work Group and the National Forest Resource Advisory Committee.
- Working in partnership, RGS and the US Forest Service maintained nine hunter walking trails totaling 36.7 miles of trail and 60 acres of wildlife openings on the East Side of the Chequamegon/Nicolet National Forest. Special thanks go out to the RGS volunteers coordinated by the NE Wisconsin and Chain O'Lakes Chapters that helped on this project on three work days.
- RGS habitat equipment (forestry loader with mulcher) completed over 165 acres of habitat work in Wisconsin this year. Since its arrival in 2009, this piece of equipment has treated over 400 acres.

## **Help RGS Protect Firearm Hunting on National Forests**

### **Comments Needed by December 21<sup>st</sup> on Huron-Manistee NF Proposal**

A September 2010 federal court ruling on the Forest Plan for the Huron-Manistee National Forest in central Michigan set a troubling precedent that could pose a serious threat to hunting on portions of our National Forests and other federal lands. The ruling by the 6th Circuit Court of Appeals directed the Huron-Manistee to consider banning firearm hunting on 66,000 acres designated as Semi-primitive/Non-motorized and Wilderness Areas of the Forest.

In response to this court ruling, the Huron-Manistee National Forest solicited input from the public and conducted an in-depth assessment of hunting on the Forest and surrounding public and private lands. The input received from the general public was overwhelmingly in support of continuing to allow hunting on the 66,000 acres in question. The Forest leadership heard the general public loud and clear and is indeed proposing to continue to allow hunting on all of the areas where it has been challenged. However, hunters aren't out of the woods yet. The Huron-Manistee is required to again solicit public input in response to its proposal and it's extremely important that the public again voice its support for hunting on the Forest.

Please take a few moments to send your own e-mail or letter to the Huron-Manistee National Forest to help protect hunting on the Forest. Your communication should reference the following:

1. Support the proposal announced by the Forest on September 23rd, 2011, to continue to allow firearm hunting on all 66,000 acres where hunting has been challenged.
2. The important role played by National Forests and other public lands in providing opportunities for hunting and other outdoor recreation as access for hunting, birding, etc. on private lands continues to diminish.

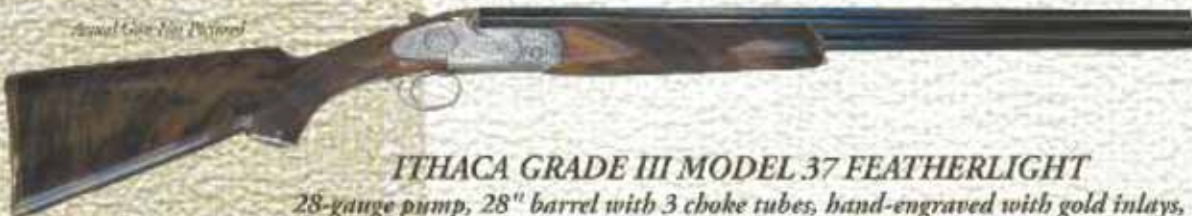

## **Michigan DNR Authorizes Purchase of 2,354 Acres to Create Menominee River State Recreation Area**

Michigan DNR Director Rodney Stokes has authorized the Department to proceed with purchasing 2,354 acres in Menominee and Dickinson Counties in the Upper Peninsula to create the Menominee River State Recreation Area. The DNR will purchase the land for \$2,534,400 in funding from the Michigan Natural Resources Trust Fund and DNR land Exchange Facilitation Fund. The land is currently owned by Wisconsin Electric Power Company.

The acreage includes two separate tracts – Piers Gorge and Quiver Falls. Piers Gorge is located one mile south of Norway and includes 145.35 acres of land and 1.5 miles of access along the Menominee River. The acreage includes whitewater rapids and waterfalls, and contains some of the fastest moving water in Michigan or Wisconsin.

Quiver Falls is eight miles south of Piers Gorge and contains 2,208.83 acres of land and provides eight miles of access along the Menominee River. It is adjacent to the existing Menominee River Natural Resource Area, a 4,450 acre tract along five miles of the Menominee River managed by both the Michigan and Wisconsin DNR's. This parcel contains river frontage, scenic rocky gorges with significant drops in the river and waterfalls.

### **2011 Wisconsin Coverts Project Reunion and Advanced Training**

Minong, Wisconsin---Ruffed grouse and woodcock depend on young forest habitat; that is no secret. And, in Wisconsin, hundreds of landowners have learned that direct correlation through the Wisconsin Coverts Project. In 2011, Coverts celebrated its 17<sup>th</sup> anniversary with a regular session for private landowners followed by a special reunion and advanced training for all past participants. The reunion and advanced training, held August 26 – 28 at the Heartwood Conference Center near Minong, attracted 80 landowners who had attended workshops from 1994 through 2010.

Coverts is co-sponsored by the Ruffed Grouse Society (RGS), Louisiana-Pacific Corporation, UW-Extension, UW-Madison Department of Forest and Wildlife Ecology, and Sustainable Forestry Initiative, Inc. In addition, the Anne and Jason Spaeth family, Braun Woodlands, and Howard and Nancy Mead were sponsors of the reunion.

Jamie Nack, Wisconsin Coverts Project Coordinator for the UW-Madison Department of Forest and Wildlife Ecology, said that since 1994, 505 cooperators have been trained. They own 440 different properties totaling over 180,000 acres. "This is an important group to reach," Nack said, "because 67% of woodlands are owned by non-industrial private forest landowners." Cooperators are urged to manage their property for wildlife and also share information with their neighbors and other landowners.

"The project was originally started and funded by The Ruffed Grouse Society, as a way to reach out to private landowners," Jamie Nack said. The project has evolved over the years, with the help of grants from other organizations but RGS is still actively involved and the benefit can be seen when talking to the private landowners who attend.

"More than 60% of the people who attended the workshops found that the workshop changed their view of managing their land, and the rest said it reinforced their thinking," Nack said. One person noted that one of the best attributes about the workshop is that it "makes us think about actively managing our properties."

Applications are available from Nack and are due by June 15, 2012.

## **Private Lands Available for Hunting in Wisconsin**

At least 138 private properties totaling over 12,000 acres are now open for hunting, fishing, trapping and wildlife viewing under the Voluntary Public Access (VPA) program offered by the Wisconsin Department of Natural Resources. This program provides financial incentives to private landowners who open their property to these recreational activities. Funding for this program was authorized in the 2008 Farm Bill. The VPA lands open for public use are located in the southern two-thirds of the state, in areas with a limited amount of public land available.
